GENERAL TERMS OF CONTRACT

1. Introductory provisions

- 1.1. The purpose of the Hauser Music Foundation is to help and support people in developing countries, areas affected by disasters, as well as those living in poverty and illness all over the world, the focus of which is financial assistance, the creation and operation of projects that support the realization of the above goals, and the organization of education, cultural and leisure programs. In addition, being aware that there are many people with outstanding musical talent in the world, however, due to financial or other reasons, it is not possible to have broader and deeper musical knowledge, so they are not able to use their talent, realizing that the search for and support of talents is related to a long-term goal the provision of significant financial resources necessary for the performance of tasks, therefore it establishes a founding foundation to perform these tasks at an appropriate level.
- 1.2. This General Terms and Conditions (hereinafter: GTC) contains the conditions of the support contract between the Hauser Music Foundation and donators, as natural or legal persons, who provide financial support to the Foundation at the expense of their own assets.

2. Definitions

- 2.1. Foundation: HAUSER MUSIC FOUNDATION (seat: 1025 Budapest, Páfrány út 23/B., tax number: 19338482-2-41, Court registration number: 01-01-0013303. represented by: President Roland Horváth)
- 2.2. Donation: voluntary contributions in money provided by the Donator to the Foundation to achieve the Foundation's goal.
- 2.3. Donator: the natural or legal person who voluntarily provides money to the Foundation to achieve the Foundation's goals and accept the provisions of this GTC.
- 2.4. Donation Agreement: The contract between the Donator and the Foundation, which is created by the completion of the donation.

3. Acceptance of the GTC, conclusion of the contract

- 3.1. In the framework of the Donation Agreement, the Donator provides financial support to the Foundation to achieve the Foundation's goals stated above.
- 3.2. By providing the donation, the Donator accepts the provisions of this GTC and declares that (s)he is a natural or legal person capable of acting. If the court has partially limited the donator's ability to act for certain types of matters, in that case, the Donator declares that the restriction does not affect the possibility of providing the Donation, or the restriction exists the Donator has the appropriate approval. By making the Donation, the Donator

also declares that he/she has decided on the Donation, its amount and method voluntarily, of his/her own decision and without influence.

- 3.3. The Donation Agreement is concluded by the donator's fulfilment of the Donation and acceptance of this GTC.
- 3.4. The parties declare that the purpose of the donation given in the Donation Agreement is to aid the Foundation to achieve its goals detailed above.
- 3.5. To achieve its goals, the Foundation can be supported by a Donation of any amount of money either once or regularly.

4. Method of donation

- 4.1. The donation is paid via Stripe, PayPal or by bank transfer to the foundation's account below:

5. Termination of the Donation Agreement

- 5.1. In the case of a one-time donation, the Donation Agreement is terminated after the Donation has been completed.
- 5.2. The Donor cannot be obliged to provide additional support or perform other services after the termination of the Donation Agreement.
- 5.3. In the case of regularly provided donation, a Donation Agreement of indefinite duration is established between the Donator and the Foundation, which the Donor can unilaterally terminate with a written statement addressed to the Foundation's board of trustees, with immediate effect and without reason. The Donator does not have the right of withdrawal with respect to the Donation already provided.

6. Waiver of the right to reclaim

- 6.1. By accepting the General Terms and Conditions, the Donor irrevocably waives the possibility of reclaiming the Donation under any legal title.

7. Data protection provisions

- 7.1. By providing the Donation, the Donator gives her/his consent for the Foundation to handle the data's of the Donator, which it has become aware of during the execution of the Donation Agreement, within the framework of the law.

- 7.2. The Foundation is entitled to retain the data related to the Donation Agreement for 5 years, after the performance of the Donation Agreement. After the expiration of this deadline, the Foundation is obliged to delete all the Donator's data, unless the Donator has concluded a new Donation Agreement with the Foundation.
- 7.3. The Donator by performing the Donation Agreement contributes to get newsletters or other inquiries from the Foundation. The Donator has the right to withdraw her/his consent according to this point by means of a notification sent by e-mail. After receiving the notification, the Foundation is obliged to immediately delete the data of the Donator which are related to sending newsletters.
- 7.4. Additional information on data protection can be found in the data protection information sheet.

8. Closing provisions

- 8.1. The performance of the Donation is not considered a product sale or service performed in exchange for consideration, therefore the Foundation is not obliged to issue invoices or provide receipts.
- 8.2. These General Terms and Conditions are accessible and readable by anyone on the Foundation's website. By providing Donation, the Donator declares that she/she has examined and familiarized her/him with the provisions of these General Terms and Conditions, and that the Donator accepts and recognizes the provisions contained therein as binding on her.
- 8.3. Hungarian law governs these Terms and Conditions and the Donation Agreements created on GTC basis. In matters not regulated in these General Terms and Conditions, Act V of 2013 on the Hungarian Civil Code and the provisions of other effective Hungarian legislation shall be applied. These Terms and Conditions enter into force and are valid on October 20, 2022. The Foundation may amend the provisions of these Terms and Conditions at any time. The amendment does not apply to already provided Donations or their use.
